# PHILANTHROPIC Lora Thompson

I know that all of you are doing great things this year philanthropically. Keep up the good works and let me hear from you.

In reporting hours and monies from a local project going to different organizations, divide the money given to any one organization by the total money raised, for the % rate. The total project hours is then multiplied by the % rate to arrive at the number of hours to report for that organization donation. Money collected can only be counted when it is donated to some organization.

### **BEDRE FINE CHOCOLATE & CHOCOLATE FACTORY**

Bedre started their business in Ada, Oklahoma and soon moved to Pauls Valley, Oklahoma in 2004.

Bedre, which simply means "better" is owned and operated by The Chickasaw Nation. Bedre is a Native American company producing fine chocolate.

Their chocolate is made from the best ingredients and the recipe is an age-old secret that makes it a better choice for everyone.

Delivered by the Mayas through ancient tribal trade routes, and cultivated by the Olmecs and Toltecs, cocoa is truly a delicacy with a rich history. From the European's first contact with the Aztecs in the early 16<sup>th</sup> Century, to our taste buds today, chocolate has truly been Native American's gift to the world.

Today, the Chickasaw Nation, in conjunction with its strong lineage to Aztec culture, is the only modern American Indian tribe to produce fine chocolate for our culinary pleasure.

The company offers tours of which you can see the entire assembly line. You can see the entire making from the beginning to the ending of how they package it ready for shipping.

Chocolate has to be kept warm in large round stainless steel barrels and is stirred constantly. It is molded, then enters a cooling assembly line where its cut into chocolate bars.

The chocolate covered chips is known as their signature product. They also offer the Oklahoma Cow Patty, Shark Teeth, Twists, Bedre Black Gold Bars, Caramel Filled Meltaways, Sensations, Clusters and several others.

Their products can be purchased locally in Oklahoma City at the Route 66 store and the Gourmet Gallery in Edmond, Oklahoma



#### **BRYANT PECAN COMPANY & CANDIES**

The Bryant family began commercially harvesting pecans in 1984 near Ada, Oklahoma—the heart of native pecan country.

Today, the Bryant family harvest pecans within a 60-mile radius of Ada. Each year, the family manages more than 6,000 trees throughout the year.

The pecan season starts in the spring and summer when trees are sprayed with nutrients such as zinc that are often lacking in pecan trees.

A shaker clamps around the tree truck. You can literally feel the earth move as the pecans fall to the ground. Next a stick rake is driven around the tree after it has been shaken to collect the large limbs that have fallen. A harvester, similar to a small combine is driven around the tree. Rubber fingers flip the pecans off the ground into a hopper. The harvester dumps the pecans into a pre-cleaner that blows out much of the lightweight pecans and trash before it is hauled to the cleaner.

The pecans are dumped into an elevator that feeds the pecans through a final cleaner where the pecans will be sized and inspected. The pecans are visually inspected on a motorized belt. Bad pecans, rocks, sticks and other trash are removed by hand. After the pecans are cleaned, they are dumped into a supersack that holds approximately 1,300 lbs. of pecans, and weighed. When enough pecans are cleaned, they are loaded into a truckload of more than 40,000 lbs. and shipped to a sheller.

After the pecans are shelled, the Bryant family uses the pecans to make many candies and other products.

Pecan oil for example is a healthier alternative than most oils and butters. It leaves no aftertaste and is neutral in flavor. However, it brings out flavors when used in cooking.

Pecans raise Vitamin E levels and may support intestinal health. It has been proved to increase levels of dietary fiber, thiamin, magnesium, copper and manganese.

Pecans should be stored in a refrigerator in a tightly-covered container.

Pecans will keep indefinitely at 0o F or below and may be refrozen many times without quality loss.

Some of the candies offered is Pecan Fudge, Pecan Butter, Chocolate Covered Pecans, Chocolate Toffee Pecans, Butter Toffee Pecans, Praline Pecans, Pecan Brittle, Butterscotch Pecans, Pecan Pralines, Oklahoma-Shaped Pecan Soap, Soup Mixes, Syrups and many other products.


