Executive/General Board Meeting  
March Minutes  
March 21, 2009**

The March meeting for the Executive and General Board was called to order at 9:30 a.m. by President, Bunnie Sullins, at Freddie's Restaurant in Sapulpa. No guests present. District II was recognized as the hostesses for the day.

The committee to read the minutes of the November meeting was Billie Fritch, Chairman, Gwen Beasley and Donna McCandless. Billie Fritch reported that the minutes were correct and will be filed as printed. The committee to read the minutes of the March meeting is Judi York, Chairman, Tina Davenport-McKamie and Billye Hansen.

The Corresponding Secretary's report was printed and made available to the members at the Registration Desk.

The Treasurer's report is also available at the Registration Desk. Robyn advised that she will be closing the books on April 1<sup>st</sup>. So, any reimbursement requests need to be turned in.

Parliamentarian, Jennye Hickman, presented the proposed bylaw changes to the Board members. The vote was 15 yes and 12 no. Motion carried. Jennye moved that the suggested change for Article IX, to delete the board position Junior Circle of Life, be accepted. Cheryl LaMascus, Senior Membership seconded the motion. Motion carried. Jennye moved that the suggested change for Article IX, to delete the board position Junior Membership Chair, be accepted. Jacque Edwards, Second Vice President, seconded the motion. Motion carried. Jennye advised that the proposed bylaw changes will be printed in the April-May issue of the Petticoat Journal and voted on at State Convention.

Past IC President, Cathy Holsted, reported that the International Council does not have a bid submitted for the 2012 IC Convention. She asked if Oklahoma would bid. &nb sp;Cathy would be chairman. Aletha Bolt agreed to co-chair. It could be held in the OKC/Norman area. The last IC Convention, Oklahoma hosted, was in 1997.

Convention will be in San Antonio, Minnesota and Kansas the next few years. Maxine Wheelan moved that we submit a bid to host the 2012 IC Convention. Tina Davenport-McKamie seconded the motion. Motion carried. Cathy advised that she will present this to the members this afternoon, at the council meeting.

Webmaster, Aletha Bolt, asked all board members to check their Oklaesa account and clean out the inbox. Any questions about the website or email talk to her. Bunnie asked all board members to read the duties in their Blue Book. She read over a Convention duties handout.

### Suggested Bylaw Changes – Presented March 21, 2009

Only proposed changes are printed; reasons for the changes will be read during the meeting

The First Vice President by virtue of her office shall be known as President Elect. The First Vice President shall assume the duties of the President in the event the President is unable to do so. She shall serve as Chairperson of the Nominating Committee, prepare copies of the ballot and deliver to the Credentials Chairperson prior to convention. She shall be advisor to the District Coordinators and Vice Coordinators. The First Vice President shall be an authorized signer of all Oklahoma State Council bank accounts and shall be bonded. She shall be installed President at the convention following her term as First Vice President.

CHANGE TO ADD AFTER “The First Vice President shall assume the duties of the President in the event the President is unable to do so”:

ADD: SHE SHALL SERVE AS MEMBERSHIP CHAIRMAN

**Auditor, Mona Martin**, advised the pre-audit was completed for State Project, Treasurer and the State Convention Fund. The final audit will be completed at Convention.

**Awards, Connie Johnson**, needs all years of service pins that are to be awarded at Convention. She needs the recipient's name, chapter, city and number of years of service.

**Convention Chairman, Priscilla Drummond**, warned everyone that convention security is very tight and to be careful with purses, especially in the casino area.

**Chaplain, Peggie Sprinkle**, advised the members that the Celebration of Life Ceremony will be on Sunday morning before the Second General Assembly. She is asking for a member from the following chapters to contact her for participation in the ceremony. Alpha Epsilon, Alpha Theta, Beta Mu, Delta Epsilon, Delta Kappa, Delta Lambda, Epsilon Beta, Eta Mu, Gamma Delta, Gamma Kappa and Nu Delta. Peggie would like members to continue to contact her with sisters that are in need of thoughts and prayers.

**Credentials Chairman, Marcie Lucas-Ellington**, stated no report.

**Directory Chairman, Nancy Buck**, advised that the price of the directory will remain the same.

Peggie Sprinkle announced that she was donating the \$50.00 she won in the 50/50 Easter Seals drawing, back to Easter Seals.
