### Jr. Past President/Disaster Fund Chairman Ramona Paine

Many years ago, the International Council realized that ESA sisters give thousands of hours of their time and millions of dollars to hundreds of worthy causes, but there was no money set aside for an ESA sister in dire need.

In 1956, members of a Marysville Chapter (state unknown) had lost everything they owned through a disaster. A letter was sent to ESA International stating that ESA always helps others, so why not establish a fund that would help our own sisters. The Executive and General Board thought it was a great idea and created the Disaster Fund of ESA. The donation at the time was set at \$.25 per member.

The purpose of the ESA International Disaster Fund is to assist an ESA member whose home and/or personal belongings are destroyed or damaged extensively by one of nature's causes – fire, flood, etc. Assistance may also be given when a member incurs heavy financial responsibility due to a debilitating illness or accident which involves her or the immediate family *who reside in her home and for whom she is legally responsible*. The disaster fund is not intended to be an on-going source of assistance or to cover unemployment for any reason other than illness or natural disaster.

### Eagle Facts

The world's 59 species of eagles are found on every continent except Antarctica. There are four major groups of eagles: fish eagles, booted eagles, snake eagles and giant forest eagles. America's eagles are the Bald Eagle, which is a fish eagle, and the Golden Eagle, which is a booted eagle. Golden and Bald Eagles both reside in the United States.

The Bald Eagle (*Haliaeetus Leucocephalus*) is the only eagle species living strictly in North America. It is a fish eagle that has a presence in every state in the U.S.A. except Hawaii. The Bald Eagle can have a wing span of up to eight feet and can weigh up to 15 pounds. It inhabits areas near large bodies of water where there are plenty

of fish to eat and tall trees in which to nest and roost. Bald Eagles are monogamous and remain faithful to their mate until death. Females lay one to three eggs annually in the spring time, and the incubation period is approximately 35 days.

FIRST GENERAL ASSEMBLY**

Saturday, April 26, 2008  
Crowne Plaza Hotel, Oklahoma City, Oklahoma

Following a beautiful flag ceremony by Nellrita Barrick, Cathy Holsted presented Oklahoma State Council President Ramona Paine, who declared the 65<sup>th</sup> Annual State Convention into session. All present stood and joined in the Opening Ritual.

Chaplain Joy Agan gave the devotional and inspirational thought for the day.

Cathy Holsted welcomed the membership and guests to the convention. Alan Sims of the Oklahoma City Convention and Visitors Bureau welcomed the convention to Oklahoma City, and Lora Thompson, Sooner Seniorett 1997-1998, gave the response to the welcome. President Ramona Paine introduced the 2007-2008 Executive and General Board, our International Council Representative, Rose Pasillas, and IC officers and board members.

Parliamentarian Joyce Gibson-Madden read the convention rules and moved the rules be adopted. Billie Hansen seconded the motion, and the motion carried.

Lola Jaegers moved the convention program be adopted as printed and distributed to the paid registrants of the convention. Judi York seconded the motion, and the motion carried.

The committee to read the minutes for the 65<sup>th</sup> Oklahoma State Convention is Wanda Lucas, chair, Dana Terrell and Daleene Sumrall.

Maxine Wheelan reported the minutes of the March State Council Meeting were correct as printed.

Credentials Chair Virginia Taylor reported 39 chapters eligible to vote, 32 chapters in attendance eligible to vote, and a total of 61 eligible votes in attendance, and moved the report be adopted. Margaret Kramer seconded the motion, and the motion carried.

Corresponding Secretary Vivian Gibson read regrets from Sooner Senioresses Ardyce Briggs, Dana Chase, and Betty Wilmot, and District Coordinators Rita Haines and Mary Toole.

Recording Secretary Jennye Hickman reminded chapters to submit roll call registration cards following the session.

Treasurer Gwynn Nell Swanson reported \$4,276.10 transferred from 2006-2007, receipts of \$11,457.02, disbursements of \$9,523.52, and a balance of \$6,209.60 on April 26, 2008.

State Project Report Jacque Edwards reported \$3,717.85 transferred from 2006-2007, receipts of \$4,758.00, disbursements of \$3,717.85, and a balance of \$4,758.00 on April 23, 2008. Of the disbursements, \$2,776.76 was given to Oklahoma School for the Deaf, and \$1,986.24 was given to Oklahoma School for the Blind.

2003-2004 International Council President Rosalie Griffith introduced IC Representative, Recording Secretary Rose Pasillas, who gave the keynote address.

First Vice President Bunnie Sullins gave the report from the nominating committee, introducing the candidates for the 2008-2009 Oklahoma State Council: Petticoat Journal Editor, Charlene Law; Treasurer, Robyn Ryan; Recording Secretary, Joyce Gibson-Madden and Linda Southerland; Parliamentarian, Jennye Hickman; State Project Director, Mary Ann Jones; Second Vice President, Jacque Edwards and Gwynn Nell Swanson; First Vice President/Nomination Chairman, Deb Hughes; and President, Bunnie Sullins.

President Ramona Paine declared nominations closed as no notifications of intent to nominate from the floor had been received. Tellers for the State Officers Elections were June Miller, Head Teller, Margaret Cramer, Sue Warner, and Louise Maloy. The tellers collected the ballots, and Vivian Gibson escorted the tellers and Bunnie Sullins to the Derrick Room for ballot tallying. Delores Armstrong accompanied the group to serve as messenger. Vivian Gibson returned to the assembly room to indicate the tellers were installed.

Barbara Stapleton, Jacque Edwards, Patsy Timmons, Billie Hansen, and Gwen Beasley were nominated to serve on the 2008-2009 Nominating Committee. Shelly Labus moved nominations cease. Deb Hughes seconded the motion, and the motion carried. Tellers for the election of 2008-2009 Nominating Committee were Billie Fritch, Head Teller, Connie Johnson, Linda Douthit, and Betty McCallister. The tellers collected the ballots, and Vivian Gibson escorted the tellers to the Gusher Room. Barbara Eck accompanied the group to serve as messenger, and Vivian Gibson returned to the assembly room to indicate the tellers were installed.

2008 Convention Registration Chair Linda Southerland reported registration of 151 women, 24 men, 3 DESAs, 1 MAL, and 5 guests, for a total registration of 184.

Chassidy Satterfield of ALSAC introduced our St. Jude patient and his mother, who gave a report of their St. Jude experience.

There was no old business.

Project Director Jacque Edwards moved the re-adoption of Oklahoma School for the Deaf and Oklahoma School for the Blind as State Projects for the next three years. Virginia Taylor seconded the motion, and the motion carried.

Parliamentarian Joyce Gibson-Madden presented the following proposed By-Laws Changes:

1) Article IV - Officers, Section 1

The elected officers for the Council shall constitute the Executive Board which shall include the following: President, First Vice-President Second Vice-President, Parliamentarian, Recording Secretary, Treasurer, Project Director, Petticoat Journal Editor, Junior Past President, Senior Past President, and District Coordinators. The Corresponding Secretary shall be the choice of the President-Elect. She shall serve as a voting member of the Executive Board.

Joyce Gibson-Madden moved the Corresponding Secretary should have voting privileges on the Executive Board. Wanda Lucas seconded the motion, and the motion carried.

2) Article IX - General Board, Section 1

Composition - The standing committees of this Council shall be: Association of the Arts, Auditor, Awards, Chaplain, Senior Circle of Life, Junior Circle of Life, Contest, Convention, Credentials, DIANA, Directory, Easter Seals, ESA Foundation Counselor (2 years), Senior Membership, Junior membership, Outstanding Chapter, Outstanding Youth, Philanthropic, Publicity,

Scrapbook and Sooner Seniorette President, International Officers, Past International Council President(s), and past and current ESA Foundation Board Members.

Joyce Gibson-Madden moved the Corresponding Secretary be deleted from the standing committees. Lora Thompson seconded the motion, and the motion carried.

3) Article XV - Executive and General Board Meetings, Section 5

Each member of the Board shall be required to keep a written record of work done pertaining to her office or committee and deliver to her successor at the close of annual convention.

Joyce Gibson-Madden moved the annual report be eliminated and each member of the Board is required to keep a written record of work done pertaining to her successor. Linda Southerland seconded the motion, and the motion carried.

Second Vice President Deb Hughes moved the 2010 Convention be held at the Tulsa Radisson Hotel April 30-May 2, 2010. Darlene Cushenberry seconded the motion, and the motion carried.

President Ramona Paine recognized the 3 pledges, 2 DESAs, and all chapter presidents with a president's charm. Senior Membership Chair Barbara Stapleton introduced the 60 members of the Jonquil Society, who had pledged a total of 90 new members during the past year.

Awards Chair Joyce Lacey-Kenney recognized four First Pearl recipients, and gave service pints to those members with 25, 30, 35, 40, 45, 50, and 55+ years of service. Aletha Bolt was presented her 5<sup>th</sup> Degree Pallas Athene.

Rosalie Griffith gave the closing thought, and following announcements, President Ramona Paine declared the session in recess, to reconvene on Sunday morning at 9:15 a.m.
