**Health Tip:**

**Drinking low-fat chocolate milk after a workout helps endurance, build muscle, reduces fat, and seems to improve performance, according to new research.** The drink seems to have the right combination of carbohydrates and protein, says researcher John L. Ivy, PhD. Department chair of kinesiology and health education at the University of Texas at Austin. “When recovering from exercise, two things you want to do

is replenish sugar stores in the muscle and turn on protein synthesis and stop protein breakdown,” says Ivy. “The combination of carbohydrate and protein [found in chocolate milk] work synergistically to do those two things.” The low-fat chocolate milk beat out two other drinks tested – a no-calorie beverage and a carbohydrate drink with no protein.

### **EDUCATIONAL: Healthy Snacking** **Tina Davenport-McKamie**

Between work, laundry, and chasing the kids, it feels like there is no time for healthy eating. And when you do stop to eat, it’s tempting to go the quick and easy route by grabbing a burger and fries, potato chips, or candy. But it is possible to treat yourself to a healthy snack. In fact, if you have a hectic schedule, it’s even more important to eat healthy foods that give you the fuel you need to keep going. Even if you take time to eat three meals a day, you may still feel hungry at times. Snacking on nutritious food can keep your energy level high and your mind alert.

You need to pay attention to what you eat. Stuffing your face with a large order of cheese fries after a stressful meeting may give you a temporary boost, but a snack this high in fat and calories will only slow you down in the long run. To keep energy levels going (and to avoid weight gain) stay clear of foods with lots of simple carbohydrates (sugars) like candy bars and soda. Look for foods that contain complex carbohydrates like whole-grain breads and cereals and combine them with protein-rich snacks such as peanut butter or yogurt.

Choosing healthy snacks means shopping smart. Be cautious of the health claims on food packages. Listed are a few things to watch out for:

1. Just because something is “all natural” or “pure” doesn’t necessarily mean that it’s nutritious. For example, “all natural” juice drinks or sodas can be filled with sugar but all that sugar means they will be high in calories and give you little nutrition.
2. A granola bar is a good example of a snack that seems healthy. Although granola bars can be a good source of certain vitamins and nutrients, many also contain a great deal of fat, including a particularly harmful type of fat called trans-fat. On average, about 35% of the calories in a regular granola bar come from fat. And, there can be a lot of sugar in granola cereals and bars.
3. Be skeptical of low-fat food claims. If the fat has been eliminated or cut back, the amount of sugar in the food may have increased to keep that food tasting good. Many low-fat foods have nearly as many calories as their full-fat versions.

Whatever claims a food’s manufacturer writes on the front of the package, you can judge whether a food is healthy for you by reading the ingredients and the nutrition information on the food label. And, be sure to read the serving information. What looks like a small package of cookies may contain 2 or more servings which means double or even triple the amounts of fat, calories, and sugar shown on the label.

What is the best low calorie snack to have during the day? A great low calorie snack should have a lot of fiber, some healthy fats, some protein and no added sugar. How about an apple or other piece of fresh fruit and a dozen roasted almonds (about one ounce)? This would give you about 150 to 170 calories, some protein, healthy fats from the almonds, and over five grams of fiber to fill you up and keep your digestive system healthy.

Almonds have been shown to be good for our hearts and apples contain quercetin and other anti-oxidants to keep you healthy.

As with everything, moderation is the key to smart snacking. People who eat regular meals and healthy snacks are less likely to overeat than people who skip meals or go for long periods without eating and then scarf down a large order of fries.



## Treasurer's Report

Hello ESA Sisters!

I hope everyone is doing OK in this blistering Oklahoma heat. Try to keep cool and stay well.

At the June State Council Meeting, the 2011-2012 budget was approved and will be printed in this issue of the PJ. Please note the following changes: Item 2, of the Standing Rules now reads:

2) The state dues shall be thirty dollars (\$30.00) per chapter plus **five dollars (\$5.00) per member**. New chapters shall not be required to pay state, chapter/member dues until May 1, following the first anniversary of their charter date. New chapter members joining between May 1, and the following April 1, should submit **five dollars (\$5.00) per person** to the State Treasurer by April 1, in order to be considered for, additional voting privileges. Chapter dues shall be divided as follows:

- State Council Treasury shall receive twenty-seven dollars and fifty cents (\$27.50), of the thirty dollars (\$30.00) per paid chapter; the remaining \$2.50 per paid chapter may be loaned to the Convention Hostess to help defray convention planning expenses. State Council Treasury shall also receive the **five dollars (\$5.00) per member** component of the state dues.
- Dues are to be used to defray expenses incurred by State Officers and Chairpersons such as: postage, photocopying, supplies, gift for the Outgoing State President, State Awards, web site hosting fees and other items approved by the Executive and General Board.
- Dues shall include the travel expenses of the State President and First Vice President to one (1) meeting in each district during the year.
- Dues shall include the registration fee and hotel accommodations plus travel to the President's Leadership conference, not to exceed airline coach fare round-trip.

The budget committee, board, and members present at the State Council Meeting, voted to increase member's dues from **\$3.00 TO \$5.00** beginning with the 2011-2012 year.

Please adjust your dues to reflect this increase.

*ARTICLE V - QUALIFICATIONS OF ELECTED OFFICERS* - currently reads:

Section 1. An active chapter may nominate any member for an elected office, except Corresponding Secretary. She must be an active member of her chapter in good standing and have been an ESA member for at least two years. A candidate for elected office must have held the office of Chapter or City Area Council President and give her consent in writing. She must have attended at least one (1) previous State, convention. Consent of the candidate and her qualifications shall be sent to the Nominating Committee by March 1.

***CHANGE TO READ: ARTICLE V - QUALIFICATIONS OF ELECTED OFFICERS***

Section 1. An active chapter may nominate any member for an elected office, except Corresponding Secretary. She must be an active member of her chapter in good standing and have been an ESA member for at least two years. A candidate for the elected office of President, First Vice President, Second Vice President, Treasurer and Parliamentarian must have held the office of Chapter or City Area Council President and give her consent in writing. A candidate for the elected office of Recording Secretary, Project Director and Petticoat Journal Editor must give her consent in writing. She must have attended at least one (1) previous State convention. Consent of the candidate and her qualifications shall be sent to the Nominating Committee by March 1.

Reason for change:

It has become harder and harder to fill these elected offices. By allowing the Recording Secretary, Project Director and Petticoat Journal Editor to run for an elected office without having to serve as Chapter President will open the possibility of new members on the board and help fill those positions.

Peggie Sprinkle stated, “Upon recommendation of the Executive and General Board, I move that Article V, Section 1 be accepted as changed.” Coming from a committee, no second is required. MOTION CARRIED.

She read the following proposed change:
